	<p><b>Equipment movement kept to a minimum</b></p> <p><b>Informing players to retrieve the balls around the 3G with feet rather than hands.</b></p> <p><b>Informing players, they cannot be shouting or spitting at the session on the 3G.</b></p> <p><b>Players should all be aware of entry and exit procedures</b></p> <p><b>Players being aware of procedure if they become infected after training</b></p> <p><b>Coaches providing more regular hygiene breaks during sessions</b></p>	<p><b>No new hirer, team or coach enters the 3G stadia until the session prior has concluded, a staff member to manage movement on and off between sessions.</b></p> <p><b>Signage displayed with limited numbers in confined spaces No access to changing room facilities or indoor spaces</b></p> <p><b>Any hirer, club or team hiring the 3G on a casual basis to be provided online/contactless payment option to reduce cash handling</b></p> <p><b>Communication made to managers and players around procedure</b></p>
